Following on from our telephone call, I would like to provide more information about the issue I would like to discuss with you in more detail.

It relates to on-going discussions on the setting of 'import tolerances' (trading standards for pesticides on agricultural commodities). This is an issue that is currently being discussed and could have a significant impact on ag.trade.

I enclose a copy of a letter sent to DG SANTE on this issue (as well as the SANTE response for completeness). This is however an on-going discussion which raises some questions of 'Better Regulation'. I would welcome the opportunity to explain our concerns and to provide any clarification.
