You may recall our previous communication on this matter, dated July 29th 2022, which reflected IATA's concern about the intentions of the Dutch Government to reduce capacity at Amsterdam airport.

We are now even more concerned with the Temporary Regulation that the Dutch Government is now introducing in order to implement the aforementioned measure.
