My name is [REDACTED] and on the 1 of July I took over as [REDACTED] [REDACTED] KLM Royal Dutch Airlines from [REDACTED], who I understand you know well.

It would be a pleasure for me to schedule a short introductory meeting with you, where I think virtually would be most easy to organise on a short notice.

Beyond an introduction from my side, I would be eager to learn how you personally see the recent announcement of the Dutch Government to limit the number of flight movements at Schiphol from the current 500.000 a year (where 540.000 was promised, under conditions) to 440.000 a year from 2023. I saw remarks from you in the media, while at the IATA AGM, where you rightly say that beyond the number we need to make aviation as such more sustainable.

Moreover, we could briefly touch upon slot relief for Winter '22 where we still see a lot of uncertainty in the market, and capacity restraints as a result of the COVID-crisis, for example when it comes to staffing at airports such as Schiphol. I would be very interested to learn how you view this.

I would be delighted to have a short introductory virtual meeting with you this week or early next if possible.
