Please see below key points from my mission to the OGMP 2.0 Annual Conference in Madrid hosted by Repsol:

- **OGMP 2.0 Governance:** had some follow up talks with Piebalgs, Manfredi and [REDACTED].

- I connected with **SOCAR** Vice President, who said that they hope to join OGMP 2.0 [REDACTED] – I offered our political support for this and mention COP29 as a venue to further work on methane.
- We invited [REDACTED] **from DoE** to come to the conference and we had the chance to sit down together with IMEO and him to discuss the MMRV. [REDACTED]
[REDACTED] more conversations to happen in Geneva in mid-March for the Global Methane Initiative (I will attend with Matthew). [REDACTED] gave a short presentation of the MMRV and the only question was from Equinor about why they are doing so as there is already OGMP.
- ENER C2 gave a presentation of the EU Methane Regulation. Building good cooperation with C2 colleagues around the regulation 😊 The Clean Air Task Force presented the Methane emissions reduction programme (MERP), as part of IRA: waste emissions charge; revision of GHG reporting program (spring 2024), 1.55billion to implement the program. GHG reporting program is level 3, now moving towards level 4 (need for measurement data). [REDACTED]
- IMEO presented the Methane Supply Index idea, positive feedback so far. Now that Methane SAT will be launched (planned for this evening) they will identify areas for detecting emissions and identify the case studies. Hopefully something else concrete to showcase at COP 😊
- I met the first **Japanese** company which joined OGMP 2.0, called Inpex. I mentioned to [REDACTED] and invited them to share with them the good experience with OGMP 2.0 + helping us to have more JP companies to join.
- I also met the first **Canadian** company who joined OGMP 2.0, called Kiwetinohk. I invited them to participate to the next EU Canada methane dialogue taking place on 12 March in Calgary and to present their OGMP 2.0 experience.
- Both **Chevron, Cheniere and ExxonMobil** attended the conference 😊
- I connected with **NGC - National Gas Company of Trinidad and Tobago Limited**, who is

developing the Dragon field gas project with Shell and Venezuela. I will follow up with them when will be the right time to discuss the Global Gateway project

- At the EU US Energy Council 2023 we witnessed the agreement between **Total Energies TADI and Colorado University METEC for collaboration on metrology**. They were both on stage to present their work. TADI asked whether the EC can host an event for them to present the draft protocol under development. I replied positively, it would be good for us to show some progress on what was announce last year. We could even suggest to expand it to mid and downstream.
